



Vaccination Guidelines

Want to maximize your investment in feeder cattle? If so, consider implementing a vaccination program into your process. Vaccinating along with good genetics and animal husbandry can increase the value when selling feeder cattle at Empire Livestock, LLC.

****EFFECTIVE IMMEDIATELY**** 2/1/24

To incentivize producers who implement Empire Livestock, LLC’s vaccination guidelines, Empire Livestock, LLC is standardizing the order in which feeder cattle are sold, as follows:

First sold, will be all **FULLY VACCINATED** feeder cattle, second sold, will be **PARTIALLY VACCINATED**, followed by **UNVACCINATED**.

Requirements for **FULLY VACCINATED**: Vaccinations must be administered **NO MORE** than **120 days prior** to sale date and required boosters must be administered **AT LEAST 30 days prior** to sale date.

Vaccinations **MUST INCLUDE** protection from the following:

- IBR (Infectious Bovine Rhinotracheitis)
- BVD (Bovine Viral Diarrhea) Type I & II
- Pasteurella
- BRSV (Bovine Respiratory Syncytial Virus)
- PI3
- Clostridial 7 Way
- Mannheimia Haemolytica

This document, along with the completed vaccination certificate, **MUST** be provided with **ALL** cattle consigned to receive preferential selling status.

In addition, we recommend following the guidance provided by your local veterinarian, the manufacturer’s instructions for administration and storage of vaccines, as well as following the Beef Quality Assurance guidelines on injections.

NOTE that medications on the Vaccination Certification Form are not brand-specific, we suggest contacting your veterinarian for brand recommendations.
